

## **DeVry University Notice of Disclosure of Education Records**

**This Notice is provided pursuant to the Family Educational Rights and Privacy Act (“FERPA,” 20 U.S.C. § 1232g, 34 CFR Part 99).**

**This Notice Applies to You if:** You enrolled in one or more bachelor’s or associate degree programs offered by DeVry University on or after January 1, 2008.

**Reason for the Notice:** DeVry University has been ordered by a federal court to provide certain educational records to the Federal Trade Commission (“FTC”). A copy of the order is available at [https://www.ftc.gov/system/files/documents/cases/161215\\_devry\\_stipulationrefinalorder.pdf](https://www.ftc.gov/system/files/documents/cases/161215_devry_stipulationrefinalorder.pdf). The FTC intends to use these records to conduct a redress program and otherwise confirm the forgiveness of certain debts. DeVry University is required under FERPA to notify you that your education records may be produced and provide you with sufficient time to move for protective action. This communication constitutes such notice.

**Records to be Provided:** The information that may be provided to the FTC includes names, student ID numbers and other numeric identifiers, amount of tuition paid to DeVry University, whether the person took out institutional/private student loans, whether the person owes money to DeVry University, last known addresses, last known email addresses, last known telephone numbers, and, as applicable, the nature, amount, and account number related to any institutional debt or loan.

**Options Available to You:** If you do not object to the production of these records to the FTC, you need not take any action and your records will be produced as ordered by the court. If you object to the production of these records, you must file an objection seeking protective action from the United States District Court for the Central District of California. Any filing should include the following caption: No. 2:16-cv-00579-MWF-S, *Federal Trade Commission v. DeVry Education Group Inc., et al.*. The filing should be sent via regular mail to:

DeVry University is required to provide the FTC with requested information unless you object. If you do not seek protective action by Tuesday, January 10th, 2017, DeVry University may disclose the above-described information to the FTC.
