

2023 DeVry University New Jersey Campus Climate Survey Results

Response Rate

102, or approximately 7.4% of the student population surveyed, responded to the Campus Climate Survey (Survey) and 56 students, or approximately 4% of the student population, completed the entire Survey. The surveyed population included any student residing in New Jersey and students that took at least one course at the Iselin, NJ location over the last three (3) sessions.
