

Steps to complete and return this form:

- If submitting in person Please schedule an appointment with a Student Finance staff member at your local campus. Section C of this form must be signed in the presence of, and presented to, an authorized DeVry University Student Finance staff member. Your citizenship and/or immigration documentation will need to be verified at that time by presenting your citizenship and/or immigration documentation along with a valid government-issued photo identification, such as, but not limited to, a driver's license, other state-issued identification, or passport.
- If submitting electronically <u>Section D</u> of this form must be signed in the presence of, and notarized by, a notary public. Your identity will need to be verified at that time by presenting a valid government-issued photo identification, such as, but not limited to, a driver's license, other state-issued identification, or passport. The citizenship and/or immigration documentation and notary seal must be visible on the electronic copy for this form to be considered valid. A copy of the citizenship and/or immigration documentation presented to the notary public to complete Section D will need to be placed in Section E of this form. Once completed, please submit this form electronically to Student Finance through email or fax 877.453.3879.
- If submitting by mail Section D of this form must be signed in the presence of, and notarized by, a notary public. Your identity will need to be verified at that time by presenting a valid government-issued photo identification, such as, but not limited to, a driver's license, other state-issued identification, or passport. A copy of the citizenship and/or immigration documentation presented to the notary public to complete Section D will need to be placed in Section E of this form.
