Your identity will need to be verified at that time by presenting a valid government-issued photo identification, such as, but not limited to, a driver's license, other state-issued identification, or passport. A copy of the piece of identification presented to the notary public to complete Section D will need to be listed in Section B and placed in Section E of this form.
