These funds are required to be provided as Emergency Financial Aid Grants to eligible students for expenses related to the disruption of campus operations due to coronavirus.

DeVry University (DVU) signed and returned to the Department of Education its **Certification and Agreement** on May 8, 2020, with our assurance that DVU intends to use 100% of the **Emergency Financial Aid Grants** to eligible students. As of June 30, 2021, we have received \$4,713,768 in grant funding for this purpose.

The institution identified 5,046 students eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 (the “HEA”) and potentially eligible to receive the Emergency Financial Aid Grants to students. Under Section 18004(a)(1) of the CARES Act, As of June 30, 2021 1,892 students have received an emergency grant. Total amount of grant funds disbursed to students at this time is \$4,713,768.
