**Institutional Accreditation**

DeVry University is accredited by The Higher Learning Commission (HLC), [www.hlcommission.org](http://www.hlcommission.org). The University’s Keller Graduate School of Management is included in this accreditation.

The HLC is one of eight regional agencies that accredit U.S. colleges and universities at the institutional level; is recognized by both the U.S. Department of Education and the Council for Higher Education Accreditation; and accredits approximately one-third of U.S. regionally accredited public and private institutions. Accreditation provides assurance to the public and to prospective students that standards of quality have been met.

DeVry University is a member of the Council for Higher Education Accreditation, a national advocate and institutional voice for self-regulation of academic quality through accreditation. CHEA, an association of 3,000 degree-granting colleges and universities, recognizes 60 institutional and programmatic accrediting organizations.

"Total Graduates Employed in field" means graduates meeting the 3 following criteria:

(A) is at least half-time.

(B) is usually filled by a person with a credential of the kind offered by the program or is one in which holders of such a credential have a competitive advantage in the workplace because of training of the kind provided by the program.

(C) employs the graduate within six months of program completion in a position that is intended to be permanent, i.e. not for a defined period of time. The school has the burden of showing that the position is intended to be permanent.

"Total graduates available for employment" means all graduates minus those who entered another post-secondary education program or the military full-time, were incarcerated, or died.

DeVry did not collect graduate employment data for graduate students during the time period identified above, for the purpose of this disclosure assume the job placement rate is 0%.

<sup>9</sup> Self-reported by students who graduated from July 1, 2014 - June 30, 2015. Students who did not report a salary or reported \$0 were excluded from the calculation.

<sup>10</sup> No students completed an undergraduate certificate program during the period of July 1, 2014 – June 30, 2015 because programs at this level were either too new or did not exist during the time period.

<sup>11</sup> There were fewer than 20 graduates in this program. Average time to graduate, graduation rate, median borrowing, median annual loan payments, job placement success and median starting salaries are withheld to preserve the confidentiality of graduates.
